The Haven's and the Baby Haven's goal is to be a place where women can recover from addictions and co-occurring mental illness, deliver healthy, drug-free infants (if pregnant), improve parenting skills and receive quality early educational services for their children, maintain and build upon cultural and family connections as sources of social support, and become self-sufficient, confident and productive members of our community. Friends of the Haven, with generous gifts from donors, renovated and furnished Building 18 on the Fort Logan campus as transitional housing for 15 women and their children who are completing residential treatment. It has been named the Lighthouse, and was completed and occupied in November of 2016. Friends of The Haven continued to award the treatment scholarships to the women in treatment at Haven. Friends of the Haven with generous gifts from donors and a matching grant from Qualistar Colorado completed a major remodel of the playground for the Baby Haven child care facility in 2019. New age related play equipment was
